	Child Care Assistance Program (CCAP)	Early Learning Scholarships
<b>Description</b>	<p>Public assistance program to help low-income families pay for child care so parents can work or pursue education leading to employment. Includes:</p> <ul style="list-style-type: none"> <li>• MFIP Child Care: families on MFIP or Diversionary Work Program</li> <li>• Transition Year: up to 12 months after eligible family exits MFIP</li> <li>• Transition Year Extension: former MFIP families in counties with BSF waiting list</li> <li>• Basic Sliding Fee (BSF): other low-income families not on MFIP</li> </ul>	<p>Scholarships for low-income families to access high-quality early learning programs. Includes:</p> <ul style="list-style-type: none"> <li>• Pathway I: Awarded directly to eligible families to use in a high quality program of their choice.</li> <li>• Pathway II: Funding paid to high quality early learning programs (not linked to individual children)</li> </ul>
	<p><i>Note that eligible families may access both Child Care Assistance Program and Early Learning Scholarships, and combine funds to cover costs of one or more eligible ECE programs. For example, an eligible family may receive a Pathway II Scholarship to attend a part-time, part-year school-based PreK program and use CCAP to pay tuition at a center or home-based provider for afternoons and summer.</i></p>	
<b>Family Eligibility</b>	<p>Children birth through 12 years 13-14 year olds with special needs Entry level income &lt;47% SMI Exit level income &gt;67% SMI (or 85% SMI if within 12 month period) Non-married applicants must cooperate with Child Support Enforcement unless good cause exists Parent must be working or engaged in approved activities (education, training, job search) MFIP has 60-month lifetime limit US Citizen or qualified non-citizen children only Family must report changes in circumstances (family size, work schedule, address) within 10 days Reauthorization every 6 months</p> <p><i>65.3% of children using CCAP are children of color (4.1% didn't provide race/ethnicity)</i></p>	<p>Children ages 3 years to K entry and their younger siblings Children 0-K with teen parent (no income limit) Income = &lt;185% FPG Family retains scholarship until child enters K without requalifying, but must fill out new application each year</p> <p><i>49.6% of children using ELS are children of color (12% didn't provide race/ethnicity)</i></p>
	<p><i>Family of Four Income Examples:</i></p> <ul style="list-style-type: none"> <li>• State Median Income (SMI): \$43,296 is 47% SMI; \$61,716 is 67% SMI</li> <li>• Federal Poverty Guideline (FPG): \$44,955 is 185% FPG</li> </ul>	
<b>Max Family Costs</b>	<p>Copay (based on family income/size) + Difference between provider's rate and CCAP maximum rate + Costs for care not covered by CCAP authorization</p>	<p>Difference between provider's rate and scholarship amount</p>
